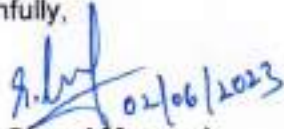

2. The Appeal has been considered in NBA. Representatives of the Institution also presented the case before the Appellate Committee at its meeting held on 01-03-2023. The recommendation of the Appellate Committee has been considered by the Competent Authority in NBA. Based on the decision taken, accreditation status of the program is given in the table below:

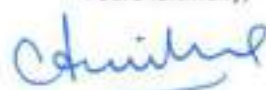
